The high school/team/booster club (hereinafter referred to as "client") must provide official permission/authorization to Booster Stores to use their logos and graphics for commercial use on the Booster Stores website and online stores.

Any logos/graphics provided by the client will remain the property of that client. The authorized logos and graphics will be provided to Booster Stores via online file transfer or via email file attachment. The client understands that the use of the logos and graphics is for the purpose of commercial sales on an online store provided and maintained by Booster Stores for the benefit of the client at the terms stated in this agreement and on the Booster Stores website.

The client understands that Booster Stores may, with approval, create, redesign, or alter logos and graphics for use on the online store, and it gives permission to Booster Stores to add new designs to their store. If any graphic design costs are incurred by Booster Stores for approved logos/designs, the cost may be deducted from the commissions earned by the client from its store. Costs will be provided to client prior to approval. There will be no out of pocket expenses for the client.

The client understands that permission to use will continue to be granted until either party cancels the agreement in writing. If cancelled by the client, Booster Stores is allowed up to 60 days for compliance in order to remove the online store from its website/servers, and to accommodate any last minute orders.

Booster Stores will pay a minimum 15% commission to the client on all sales (excluding tax and shipping) made from their store. This will be paid monthly if cumulative commission exceeds \$100. Commissions may be increased based on sales.

Client agrees to assist in marketing their Booster Stores by adding a link to their website, and by actively promoting it to their members/students/faculty, etc. Booster Stores can provide marketing assistance and expertise if requested.
